CAUTION:

On plastic surfaces a preliminary test is recommended.

APPROVALS:

The formulation of **ZEP 45 DUAL FORCE** contains only 15 % of volatile organic compounds (VOCs). This percentage is well below the limits imposed by the current European regulations concerning the presence of VOCs in chemicals.

PRECAUTIONS FOR USE:
